Miss South Gate 2008 Pageant Application

Participation Rules & Regulations...

1. Must be seventeen (17) and not more than twenty four (24) years of age on April 29, 2007. Must also provide a completed application form, \$25.00 (non refundable) fee, proof of age (photo ID), Data Sheet (short bio) and parental release (if 17 years of age) when application is turned in. Application will **not** be accepted without the items described above.
2. Must be a resident of South Gate, or be employed in the City of South Gate.
3. Must be single, never have been married, nor pregnant or have children and must remain unmarried and without children throughout your reign or you will be disqualified.
4. Must not have any type of criminal record.
5. Must be able to commit to the duties of Miss South Gate.
6. Must attend all rehearsals and portrait schedules.
7. Must wear clothing, in good taste, for judge's interview and formal gown (furnished by applicant) for the evening gown competition. You provide your own gown for the Christmas float.
8. Judging will be based on beauty, poise, personality and ability to communicate effectively.
9. Pageant participation will be limited to the first sixteen (16) qualified applicants. No applications will be accepted after March 27, 2008.
10. Miss South Gate and her court must attend all scheduled events sponsored by the Chamber of Commerce, City of South Gate and the Parks & Recreation Department.
11. Members of the current Miss South Gate Court (2007) may not compete in the Miss South Gate 2008 Pageant.
12. Individuals may compete a maximum of two years for the crown of Miss South Gate.
13. Participants must obtain a sponsor. Sponsor may be an individual or Company. Sponsors should inquire at Chamber Office for further details.
